



## **Suranaree University of Technology Regulations on Tuition Fees for Graduate Students, B.E. 2557 (2014)**

---

As it is deemed appropriate to revise Suranaree University of Technology Regulations Regulations on Tuition Fees for Graduate Students, and by virtue of Clause 16(2) and (10) of SUT Act, B.E. 2533 (1990) and the resolutions passed in the 4/2014, meeting, of The University Council meeting, 4/2014, on 26 July 2014, the University has laid down the following regulations:

1. These regulations are called, “Suranaree University of Technology Regulations on Tuition Fees for Graduate Students, B.E. 2557 (2014)
2. These regulations are effective for the students enrolled in the academic year 2015 onwards.
3. These regulations require the cancellations of the Suranaree University of Technology Regulations on Tuition Fees for Graduate Students, B.E. 2555 (2012).

In case there are any regulations, criteria, rules, resolutions, or other directives contrary to or in conflict with the current regulations, the current regulations are used to be followed.

4. The rates of tuition fees have been determined as follows:

#### 4.1 Single Payment of

General Insurance Fee: 6,000 Baht

(To be returned to the students when leaving the university upon graduation or due to the termination of student status or quitting the university. The amount returned is the final sum after deduction of, if any, costs of damage to the university’s properties and assets and other debts that the students owe to the university.)

- 4.2 Annual Fee
- 4.2.1 University Maintenance Fee: 20,000 Baht
- 4.2.2 Student Activity Fee: 400 Baht
- 4.3 Registration Fee
- The registration fee is 2,400 Baht per one academic credit.
- 4.4 Other Miscellaneous Fees and Fines:
- 4.4.1 ID card: 30 Baht per card  
(Except for the first issue and renewal of the card)
- 4.4.2 New ID card in case of loss: 200 Baht per card
- 4.4.3 Recommendations Letter: 20 Baht per letter
- 4.4.4 Student Status Maintenance: 1,500 Baht per trimester
- 4.4.5 Student Status Regaining: 1,500 Baht each time
- 4.4.6 Late Registration Fine: 75 Baht per day
- 4.4.7 Late Fee Payment Fine: 50 Baht per day

5. Charging tuition fees to graduate students whose enrolment was before the academic year of 2013 shall be in accordance with the Suranaree University of Technology's Regulation on Graduate Students' Tuition Fees 2007 and Suranaree University of Technology's Regulation on Graduate Students' Tuition Fees (2<sup>nd</sup> edition) B.E. 2553 (2010).

Charging tuition fees to graduate students whose enrollment was during the academic years of 2013 - 2014 shall be in accordance with the Suranaree University of Technology's Regulations on Graduate Students' Tuition Fees, B.E. 2555 (2012).

6. The Rector acts on behalf of these regulations and is authorized to issue additional announcements or notices concerning procedures of practices that do not contradict or in conflict with these regulations.
